# Management Discussion of Fund Performance

This management discussion of Fund performance presents views of the portfolio management team about the significant factors and developments during the past year that have affected the Fund's performance and outlook.

## Investment Objective and Strategies

The Fund aims to provide long-term capital growth, primarily by investing in foreign equity markets.

To achieve the Fund's investment objective, the Fund uses a proprietary quantitative model to assist in determining which countries to invest in and the amounts to allocate to each country. It then uses a bottom-up conservative growth investment style to uncover stocks that are reasonably priced relative to their growth potential.

## Risk

The overall level of risk of investing in the Fund remains as discussed in the Prospectus, and is not expected to have significantly increased or decreased as a result of operations during the period. Accordingly, the Fund also remains suitable for the same investors as discussed in the Prospectus.

## Results of Operations

### CHANGES IN NET ASSETS

The Fund's net assets increased by 12.0% during the period to \$643.3 million. This change was comprised primarily of gains from operations of \$57.2 million and an increase of \$11.4 million due to net securityholder activity.

### FEES AND EXPENSES

The management expense ratios (MERs) for all series except Series P are lower than the MERs for the 12-month period ended March 31, 2017 primarily due to reductions in fee rates. Total expenses paid also vary period to period as a result of changes in average assets in each series. Average net assets of the Fund for the period were \$619.6 million, an increase of 20.1% compared to the period ended March 31, 2017.

### INVESTMENT PERFORMANCE

In accordance with National Instrument 81-106, the following comparison to a broad-based index has been included to help you understand the Fund's performance relative to the general performance of the markets. However, the portfolio management team cautions that the Fund's mandate may be different from the index shown. For a description of the index, see *Annual Compound Returns*. Also, it is important to note that investors cannot invest in an index. Indirect investments in an index are available; however, there are fees and transaction costs and other variables that will impact returns when investing in these products. Index returns included in the comparison below do not reflect these costs and variables. In addition, unlike the index, this Fund may be subject to valuation adjustments as outlined in the Fund's valuation policies as it relates to non-North American equities held either directly or indirectly by the Fund. A fair value adjustment can either positively or negatively impact the Fund's rate of return.

For the returns of all series and for longer-term performance of the Fund, see the *Past Performance* section of this report. Performance will vary by series primarily because fees and expenses may differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. See *Series Information* for the annual expense rates for each series.

For the year ended March 31, 2018, the Series B securities returned 7.9% (after deducting fees and expenses paid by the Fund). In comparison, the MSCI World Index Total Return (Net) \$ CAD returned 10.0%.

The MSCI World Index Total Return (Net) \$ CAD advanced through most of the period as almost all major equity markets benefitted from improving economic data and corporate earnings growth. A strong second-half for U.S. equities, driven by corporate tax reform, added to global market optimism. A pullback in February in reaction to U.S. inflation fears was brief, although rising global trade tensions had markets again retreating from their highs as the period ended. Asia Pacific equities posted the strongest gains, driven by ongoing global economic expansion, especially in China. Japan and Europe, which experienced their best economic performance in years, saw stock gains restrained by strengthening currencies.

Stock selection in the consumer staples and consumer discretionary sectors detracted from relative performance, while stock selection in the industrials and financials sectors contributed positively to relative performance.

Stock selection in the U.S. and Israel detracted from relative performance, but stock selection in Japan and South Korea contributed positively to relative performance.

## Recent Developments

(BASED ON INFORMATION AS AT APRIL 20, 2018)

The portfolio management team's outlook for developed equity markets remains positive, supported by the synchronized upturn in global economic growth, which has supported higher earnings per share growth. However, the portfolio management team remains cautious as equities remain vulnerable to a further setback as volatility and geopolitical risk are likely to persist. In the U.S., recent tax reform and the government spending bill should continue to provide tailwinds for short-term economic growth prospects and equity market performance. The portfolio management team believes the U.S. Federal Reserve (the Fed) will remain cautious in raising interest rates this year and next, despite recent comments following the Fed's March meeting. Europe remains in the early stage of the business cycle and is experiencing an improvement in credit conditions and economic growth, driven by strong household consumption, fixed investment and exports. Any further improvement should continue to support earnings growth, alongside positive earnings-estimate revisions. The portfolio management team continues to favour Japan, as it has strong forecasted earnings growth this year against a backdrop of a better-than-expected economic recovery. However, a stronger yen has weighed on Japanese equities this year, though the portfolio management team expects yen strength to subside.

Emerging markets equities have outperformed developed market equities this year, supported by a weak U.S. dollar and despite a rise in U.S. 10-year yields. One of the portfolio management team's key concerns late last year was the narrow breadth of the rally within the information technology sector. Encouragingly, there appear to be signs that the rally has broadened to other sectors, including energy, health care and financials, which, along with information technology, have outperformed the benchmark this year. This is positive for stock selection should the trend continue. The portfolio management team remains optimistic about these markets over the medium term, as a solid pickup in global trade has supported economic growth in emerging markets. In addition, provided that trade protectionism remains somewhat muted going forward, the portfolio management team anticipates growth will continue to outpace developed market economies, which should bode well for emerging markets equities. Countries implementing meaningful structural reforms that should bolster long-term economic growth appear to offer the greatest investment potential.

## Related Party Transactions

I.G. Investment Management, Ltd. is the Manager, Trustee and Portfolio Advisor of the Fund. The Fund is offered through the Consultants of Investors Group Financial Services Inc. and Investors Group Securities Inc., together referred to as the Distributors. The Manager, Portfolio Advisor, Distributors and Trustee are, indirectly, wholly owned subsidiaries of IGM Financial Inc.

The following sub-advisor has been retained to provide investment services to the Fund:

- AGF Investments Inc.

The Fund paid a management fee to the Manager and Portfolio Advisor for management and portfolio advisory services (see *Management Fees*).

The Fund also paid the Manager an administration fee and in exchange the Manager paid the operating costs and expenses of the Fund, except for certain specified costs.

The Fund paid the Distributors a service fee as compensation for providing or arranging for the provision of services to the Fund, including the issue or allotment of securities. A portion of the service fee for Series C is rebated by the Distributors to the Fund, for distribution to Series C securityholders quarterly, as outlined in the Prospectus.

The Trustee is responsible for the overall direction of the affairs of the Fund. The Fund paid the Trustee a fee for its services.

See *Series Information* for the annual rates paid by each series (as a percent of average net assets) for these fees.

Securityholders in Series U also pay an advisory fee directly to Investors Group. This fee is not included in the Fund's expenses.

Certain other investment funds, distributed by Investors Group, and other qualified investors may invest in Series P of this Fund. As at March 31, 2018, this series comprised approximately 64.2% of the Fund's net assets. All such transactions in the Fund are executed in accordance with standing instructions approved by the Investors Group Funds Independent Review Committee and based on the net asset value per security determined in accordance with the stated policies of the Fund on each transaction day. No commissions or other transaction fees were paid by the Fund in relation to these transactions.

## Management Fees

The Fund pays Investors Group a management fee. The management fee paid by each series is calculated as a percentage of the net asset value of the series, as of the close of business on each business day (see *Series Information* for rates payable by each series). Generally, management fees are used to pay costs incurred in providing investment advisory and management services and in part for distribution-related services provided by the Distributors.

Securityholders in Series U pay an advisory fee directly to the Distributors for distribution-related services and therefore the management fee in that series is for investment advisory and management services only.

For all other retail series (i.e. which excludes Series F, P and S, if issued), approximately 55% of management fees paid during the period represents investment advisory and management services, and approximately 45% represents distribution-related services. This may vary by series.

Approximately 57% of the total fees paid by the Fund for the period relates to services provided by the Manager, Trustee and Portfolio Advisor, and approximately 43% relates to services provided by the Distributors.

Until October 31, 2016, the annual management fee rates were as follows: Series A, B and C: 2.15%; Series Josc and Jw: 1.90%; Series U: 1.15%. From November 1, 2016 to December 31, 2016, the annual management fee rate for Series U was 1.00%.

Until December 31, 2016, the annual service fee rate for Series B and Jw was 0.40%.

## Past Performance

It is important to remember that past performance doesn't necessarily indicate future performance. The returns presented below:

- assume that all distributions, except for fee rebates, are reinvested into the Fund;
- do not include sales charges, income taxes, optional expenses or advisory fees payable directly by securityholders in certain series, that reduce returns;
- show performance based on Canadian dollar returns; and
- show performance for each of the past 10 financial years, or since the series started.

Financial years are as follows:

- 2009 – six months ended March 31
- 2010 to 2018 – 12 months ended March 31

Inception dates of the series within these periods are shown in *Series Information*.

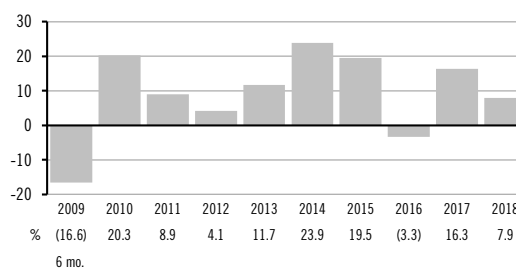
Performance during these periods may have been impacted by the following events:

- Effective July 1, 2010, the annual management fee for Series A, B and C decreased by 0.10% to 2.15%.
- Effective July 1, 2010, the administration fees for Series A and B decreased by 0.02% to 0.18%.
- Effective June 30, 2012, the annual service fee rate for Series B decreased by 0.05% to 0.40%.
- Effective November 1, 2016, the annual management fee rate for Series A, B and C decreased by 0.15% to 2.00%, for Series Jbdc and JNL the rate decreased by 0.15% to 1.75% and for Series U the rate decreased by 0.15% to 1.00%. Effective January 1, 2017, the annual management fee rate for U decreased by a further 0.10% to 0.90%.
- Effective January 1, 2017, the annual service fee rate for Series B and JNL decreased by 0.10% to 0.30%.

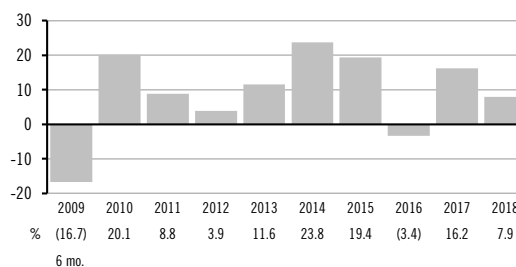
### Year-by-Year Returns

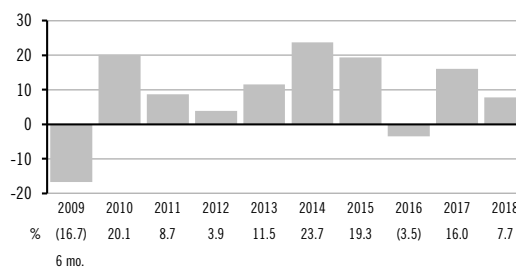

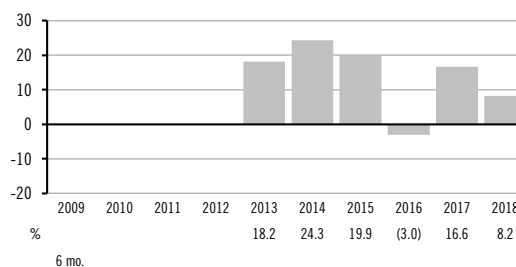

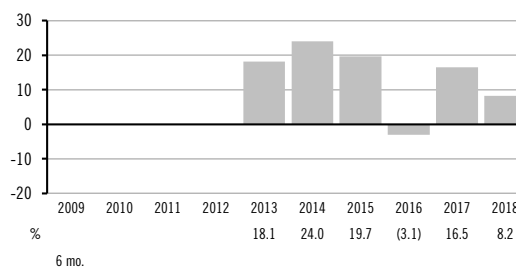

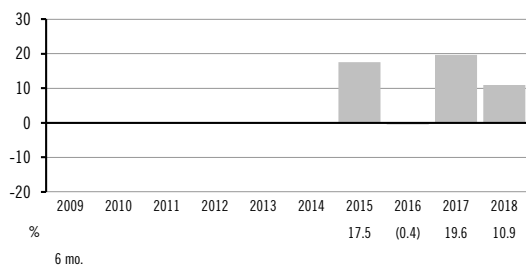

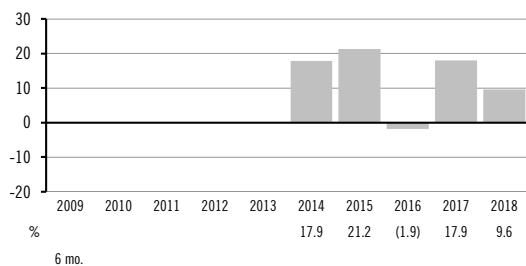

A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. Generally, the higher a Fund's portfolio turnover rate in a period, the greater the trading costs payable by it in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of a Fund. Transactions incurred to realign the Fund's portfolio after a fund merger, if any, are excluded from the portfolio turnover rate.
